Loma Linda University School of Pharmacy (LLUSP) offers an academically rigorous and personally rewarding program for those who wish to enter into the field of Pharmacy (PharmD). Our student body as well as faculty and staff are diverse both in ethnicity and religious background.

GENERAL ENTRANCE INFORMATION

Preference will be given to applicants who have successfully completed a baccalaureate degree (preferably) in chemistry, biology, physics, or a related scientific field. Students who do not have a bachelor's degree must ensure that the appropriate number of hours in general education courses have been met.

The minimum cumulative GPA and cumulative math/science GPA considered for acceptance to the School of Pharmacy is a 2.75 on a 4.00 scale. Applicants must complete the following courses with a letter grade of C or better.

Final determination of acceptability of prerequisites courses resides with the School of Pharmacy Admissions Committee in collaboration with the Office of University Records.

Please note, that in order for a course to fulfill the biology, chemistry, and physics prerequisites, it must be at the level of those required for a major in the field; introductory courses are not acceptable.

In rare circumstances a student who has not completed a Bachelor's degree will be considered for admission into the School of Pharmacy. Applicants without a Bachelor's degree must complete additional coursework as follows:

- Additional 6 semester or 9 quarter units of coursework in Social and Behavioral Sciences
- Additional 12 semester or 18 quarter units of coursework in Humanities and Fine Arts
- Additional 6 semester or 9 quarter units of English Composition.

Recommended Additional Courses:

- Cellular and Molecular Biology
- Histology
- Immunology
- Physiology

Recommended Experience:

It is highly recommended that applicants obtain volunteer or pharmacy work experience.

TRANSFER CREDIT HOURS

The School of Pharmacy does not accept transfer students with advanced standing from another PharmD Program.

APPLICATION PROCEDURES AND ACCEPTANCE

To apply for admission to Loma Linda University School of Pharmacy you must complete the following:

- PharmCAS Application
- LLUSP Supplemental Application (\$75 application fee required)
- Minimum of three recommendation letters sent to PharmCAS one of which must be from a pastor, clergy or spiritual leader
- Official transcripts from ALL post-secondary institutions sent to PharmCAS
- Academic Prerequisite Record Form (APR) available after submission of LLU supplemental application
- International students please see www.llu.edu/apply/intltrans for additional requirements.

Applying through PharmCAS

June 13, 2015 the PharmCAS application will open for filing. Visit the PharmCAS website www.pharmcas.org to establish an account and to begin an application. Detailed instructions can be found at this site to assist you in completing the PharmCAS application.

LLUSP Supplemental Application

After PharmCAS has processed your completed application, you will receive an email invitation with instructions on how to complete the online LLUSP Supplemental Application. Please note that there is a \$75 Supplemental Application Fee.

Submitting Letters of Recommendation

Use PharmCAS to submit up to four letters of recommendation. One letter of recommendation is required from a pastor or spiritual advisor. It is recommended that the remaining letters come from a science instructor and/or a professional in the pharmacy field. Committee letters of recommendation are required and only accepted from schools affiliated with the Seventh-day Adventist Church and will fulfill the three letter minimum requirement.

Submitting Transcripts for the PharmCAS Application

Official transcripts for U.S. students must be received by PharmCAS by the November 2, 2015 deadline. International transcripts must be received by LLU by November 2, 2015.

Submitting Transcripts to LLUSP

If offered acceptance, you must submit official transcripts to LLU from all post-secondary institutions from which you have attended, regardless of whether or not it applies to your prerequisite coursework. This includes all colleges, universities, military credit, and unaccredited schools. Transcripts must be sent by the issuing institution(s) directly to LLU Admissions Processing. Transcripts provided in any other manner are unofficial and will not be accepted for purposes of admission.

Academic Prerequisite Record (APR) Form

ADMISSIONS DEADLINE

PharmCAS accepts applications from July 13 through November 2 for entry in September of the following year. This deadline applies to all documents, which include application, transcripts, evaluation of international transcripts (if applicable), TOEFL scores (if applicable), and letters of recommendation. The deadline for completing the LLUSP Supplemental Application is 15 days after you receive the Supplemental Application invitation email.

APPLICATION REVIEW PROCESS

The School of Pharmacy Admissions Office reviews completed applications and accepts students on a continual basis within the period of November to March.

INTERNATIONAL APPLICANTS

Applicants who have done academic work in countries outside the U.S. must have all prerequisites completed in a two or four-year regionally accredited U.S. institution. In addition, an approved academic record evaluation for foreign transcripts is required as supplemental materials for applicant evaluation and received by LLU by November 2.

International transcripts must be reviewed by one of the following evaluation services prior to applying:

- Educational Credential Evaluators, Inc (ECE) www.ece.org
- World Education Services (WES) www.wes.org

TOEFL Test:

If the applicant's native language is not English, or if most of their education was completed in a non-English program, a score of at least 80 on the TOEFL (Test of English as a Foreign Language) is required. Some consideration is given to applicants who have earned a college degree in the U.S. Please visit www.TOEFL.org for more information.

Accepted students are required to pass a background check prior to the start of their Introductory Pharmacy Practice Experience (IPPE).
